Sub: Revision of room / bed ceilings under Medical Rules

Please refer to our IOM No. DP/2/8(A)/97 dated 26.12.07 on the revision of various ceilings under Medical Rules. It was conveyed that ceilings on bed entitlements would be revised every year on ad-hoc basis by 10% on non-cumulative basis (rounded off to nearest Rs.5/-) followed by comprehensive review after 4 years for necessary corrections. Accordingly, vide IOM No. DP/2/8(A)/19 dated 23.3.09, the revised ceilings on room / bed entitlements w.e.f. 1.4.09 was conveyed.

Further to above, we are to convey the revised ceilings on room / bed entitlements under Medical Rules to be effective from 1.4.10 :
